<b>Is there a limit on the number of times you can enter?</b>	<p>Free delivery code is valid for single use, therefore single entry per person.</p>
<b>Eligibility: Who qualifies to take part?</b>	<p>FNB Aspire, Premier, Private Clients and Private Wealth</p> <p>The Competition is exclusively for FNB/RMB retail customers who are online registered Smart Shoppers and are legal residents of the Republic of South Africa who is a natural person, 18 years of age or older at the time of purchase and has an FNB/RMB Private banking account and is a member of the eBucks Rewards Programme.</p>

#### **IMPORTANT**
