

## **eBucks 20<sup>th</sup> Birthday Superbalist Competition: Competition Rules**

Stand a chance to win one of twenty R500 Superbalist gift vouchers (each a “**Voucher Prize**”).

- 1. Promoter:** This competition is promoted by Fashion United SA (Pty) Ltd t/a Superbalist.com (reg. no. 2017/007569/07) (“**Superbalist.com**”, “**Superbalist**”, “**us**”, “**we**” or “**our**”).
- 2. Competition Period:** This competition runs from 00h00 on 20 November 2020 until 23h59 on 9 December 2020 (“**Competition Period**”). No entries will be accepted after 23h59 on 9 December 2020.
- 3. Who can enter:** You are entitled to participate in this competition if: (i) you are a natural person who is at least 18 years old and who resides in South Africa; and (ii) it is lawful for you to be awarded the particular prize. You may NOT participate if you are a supplier of goods or services in connection with this competition, or if you are a director, member, partner, employee, agent of, or consultant to Superbalist.com or any other entity which directly or indirectly controls or is controlled by Superbalist.com, or if you are any of the aforementioned persons’ spouse, life partner, parent, child, brother, sister or business partner.
- 4. How to enter:** This competition is run on the superbalist.com website, as well as related Superbalist mobi-sites and software applications, and you will need to have a valid Superbalist account to participate, AND be a member of the eBucks Rewards Programme. To enter you must, during the Competition Period, log in to your Superbalist account and complete in full at least one purchase of your choosing from Superbalist with a shopping cart value of R450 or more, AND make payment for such purchase via eBucks or using your FNB/RMB Private Bank Card (collectively a “**Qualifying Entry**”). Each Qualifying Entry will be entered into the draw and you will stand a chance to win one of the Voucher Prizes. Note that should you at any stage act in contravention of section 5 below, your entry will be withdrawn from the competition.
- 5. Content of your entry:** Your entry may not: (i) contain any foul language, obscenities, defamation, hate speech or any otherwise inappropriate content in our sole discretion; nor (ii) contain any content which may be harmful to Superbalist.com or its associated companies in any way; nor (iii) infringe the intellectual property or other rights of Superbalist.com, its associated companies or any third party. We reserve the right to remove entries which we deem to be in contravention of this section 5.
- 6. How many times you can enter:** You may enter this competition as many times as you wish during the Competition Period. Each Qualifying Entry (completed as described in

section 4 above) will give you one entry into the draw. Please note that each additional entry to your first entry must be different.

- 7. Entry fees:** There are no entry fees to participate in this competition, and no additional charges involved in acting as set out in section 4 above.
- 8. Prize:** We will randomly select twenty winners after the end of the Competition Period (i.e. twenty winners in total), in accordance with section 9 below. Each winner will receive a corresponding Voucher Prize.
- 9. Winner:** The winners will be chosen by way of random draw, at or before 16h00 on 11 December 2020. Each winner will be announced by way of direct message to his/her Superbalist login email address the first business day after the relevant draw. We will then send a direct message via the particular winner's Superbalist login email address to request his/her name, surname, email address, ID number, delivery address and telephone number ("**Participant Information**"). We will make two direct attempts to obtain such information. Once we have received this information and validated the particular winner, we will deliver the corresponding Voucher Prize to him/her as soon as possible, subject to section 10 below. Proof of identity will be required in order to validate the particular winner. We will select winners who have taken the steps set out in section 4 above and who are in compliance with these rules by way of random draw, at our sole discretion. Regarding the application of these rules and the selection of a winner and his/her prize in terms hereof, our decision is final and no correspondence will be entered into with a competition participant other than the winners.
- 10. Disqualification of winner:** There are certain situations in which a winner will be disqualified from receipt of his/her prize, namely: (i) he/she fails to provide Participant Information within 24 hours of it being requested by us for the second time; (ii) he/she is found to have contravened any other rule set out herein; or (iii) in anticipation of delivery of the corresponding Voucher Prize, he/she refuses to or cannot provide reasonably sufficient documentation to verify his/her identity. In the event of disqualification of a particular winner, we will be entitled in our sole discretion to select another winner from amongst the competition participants.
- 11. Use of participant and winner information:** By participating in this competition, you consent to the use by Superbalist.com or a third party nominated by Superbalist.com of your Participant Information, so that your name and surname can be announced as a winner and the corresponding Voucher Prize can be delivered to you. The particular winner may also be asked to permit the use of his/her image in marketing material, to participate in marketing activities, to permit Superbalist the use of the image uploaded in marketing material, and/or be present when the relevant draw is taking place or he/she is announced

as a winner, but he/she will be entitled to decline to do so. By entering this competition, you consent that Superbalist.com can use the contents of the competition submission / your winning Qualifying Entry for marketing purposes.
